The Volunteer (and Guardian) understand(s) that the Activities may include but are not limited to the following: assisting with Games while in play, traveling to and from Games venues; working in an office setting; and consuming food available or provided.

The Volunteer, or, in the event that the Volunteer is a minor child, then the Volunteer and the Guardian, do hereby freely, voluntarily and without duress execute this Release under the following terms:

1. **Waiver and Release:** The Volunteer (and Guardian) do(es) hereby release and forever discharge and hold harmless NMPMG 2022 and their successors and assigns from any and all liability, claims, and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from the Volunteer's activities with the NMPMG 2022.

The Volunteer (and Guardian) understand(s) that this Release discharges NMPMG 2022 from any liability or claim that the Volunteer, and in the event the Volunteer is a minor child, that the Volunteer and Guardian may have against NMPMG 2022 with respect to any bodily injury, personal injury, illness, death or property damage that may result from the Volunteer's Activities with NMPMG 2022, whether caused by the negligence of NMPMG 2022 or its officers, directors, employees, or agents or otherwise. The Volunteer (and Guardian) also understand(s) that NMPMG 2022 does not assume any responsibility for or obligation to provide financial assistance or other assistance, including but not limited to medical, health or disability insurance in the event of injury, illness, death or property damage.

2. **Medical Treatment:** The Volunteer (and Guardian) do(es) hereby release and forever discharge NMPMG 2022 from any claim whatsoever that arises or may hereafter arise on account of any first-aid, treatment or other medical services rendered in connection with an emergency during the activities with the NMPMG 2022 or with the decision by any representative or agent of NMPMG 2022 to exercise the power to consent to medical or dental treatment as such power may be granted and authorized in the Parental Authorization for Treatment of a Minor Child.
3. **Assumption of Risk:** The Volunteer (and Guardian) understand(s) that the activities may include work that may be hazardous to the Volunteer, including, but not limited to loading and unloading; transporting to and from various venues; and exposure to flying objects.

The Volunteer (and Guardian) hereby expressly and specifically assume(s) the risk of injury or harm in the Activities and release(s) NMPMG 2022 from all liability for any loss, cost, expense, injury, illness, death or property damage resulting directly or indirectly from the Activities with NMPMG 2022.

4. **Insurance:** The Volunteer (and Guardian) understands(s) that, except as otherwise agreed to by NMPMG 2022 in writing, NMPMG 2022 is under no obligation to provide, carry or maintain health, medical, disability or other insurance coverage for any Volunteer.

Each Volunteer is expected and encouraged to obtain his or her own health, medication, disability or other insurance coverage.

5. **Photographic Release:** The Volunteer (and Guardian) do(es) hereby consent that the Volunteer's photograph may be taken or his or her image recorded digitally or by video camera while engaged in work for NMPMG 2022 and do(es) hereby grant and convey unto Habitat all right, title and interest in any and all photographic image and video and/or audio recordings made by NMPMG 2022 during the Volunteer's Activities with NMPMG 2022, including, but not limited to, any royalties, proceeds or other benefits derived from such photographs or recordings. The Volunteer (and Guardian) do(es) further grant and convey unto NMPMG 2022 all right to identify the Volunteer by the Volunteer's name in or around any and all such photographic images and video and/or audio recordings made by NMPMG 2022 during the Volunteer's activities with NMPMG 2022
6. **Other:** The Volunteer (and Guardian) expressly agree that this Release is intended to be as broad and inclusive as permitted by the laws of the Commonwealth of the Northern Mariana Islands (CNMI) and that this Release shall be governed by and interpreted in accordance with the laws of the CNMI. The Volunteer (and Guardian) further agree(s) that in the event that any clause or provision of this Release is deemed invalid, the enforceability of the remaining provisions of this Release shall not be affected. Further, a waiver of a right under this Release does not prevent the exercise of any other right.
